

### **Janice Archer**

Janice Archer is the Adult Protective Services Casework Supervisor for Penobscot and Piscataquis Counties. She has worked for Adult Protective Services for the past eight years having been an APS caseworker prior to becoming a supervisor. Ms. Archer has a Bachelor's of Science in Health and Human Services, is a Licensed Social Worker, and has worked in the social services field for 28 years. Ms. Archer served for four years as a Commissioner on the Bangor Housing Authority Commission and for four years on the Board of the Maine Coalition to End Domestic Violence. Prior to joining APS, Ms. Archer was the Coordinator of a domestic violence shelter for seven years and has worked for Eastern Agency on Aging as well as several group homes in the area.
