Speaker Biographies

Kelley Glidden is the Director of Community Education and Youth Advocacy for Safe Voices, the domestic violence resource center serving Androscoggin, Franklin and Oxford counties. Kelley has been with Safe Voices for over ten years, and as an educator, she has provided trainings, designed education materials and participated in various community efforts addressing domestic violence. She now oversees the community education and youth advocacy program at Safe Voices, including community and school-based education and prevention, and the Batterer's Intervention Program. She has a B.A. in political science from the University of Maine and a J.D. from the University of Arizona James E. Rogers College of Law.

Sgt. Patrick Hood is a 20 year veteran of the State Police who is currently assigned to the Troop D barracks in Augusta as a patrol Sergeant overseeing the work of seven Troopers. Prior to being promoted in 2011, Sgt. Hood patrolled Knox County for 13 years where he was responsible for criminal investigations and traffic enforcement. Sgt. Hood is an active member of the Maine Council for Elder Abuse Prevention (MCEAP), a longtime member of the Knox County Triad, serves as board member for the Sexual Assault Support Services of Mid-Coast Maine (SASSMM), and is a member of the State Police pipe and drum unit. He resides in the Town of Union with his wife and their 12 year old daughter and 9 year old son.

Joe also sits on the Maine EMS Board as the chair-elect. Joe completed his undergraduate and graduate work at the University of Maine in Orono. He received his EMT Basic and EMT Intermediate through coursework at Eastern Maine Community College, and he completed his paramedic training at Kennebec Valley Community College. Sheriff Troy Morton was elected Penobscot County Sheriff in November of 2014, and assumed his new position in January 2015. He is currently the 2nd vice-president of Maine Sheriffs' Association and a member of the MSA Legislative Committee.
