

# Georgia J. Anetzberger, PhD, ACSW, LISW

Georgia J. Anetzberger is a consultant in private practice, Adjunct Assistant Professor in the Department of Medicine and Adjunct Faculty in the Mandel School of Applied Social Sciences at Case Western Reserve University, and Fellow in the Gerontological Society of America, including serving on the Editorial Board of *The Gerontologist*. She is a member of the Advisory Board to the National Center on Elder Abuse and the Steering Committee to the federal Elder Justice Roadmap. Dr. Anetzberger also is Past-President of the National Committee for the Prevention of Elder Abuse and immediate Past-Editor of the *Journal of Elder Abuse & Neglect*. She has been active in the field of elder abuse for over forty years as a practitioner, planner, administrator, researcher, and educator. Dr. Anetzberger has conducted pioneering research on such subjects as elder abuse perpetrators and cultural variation in meaning or response to elder abuse; authored more than eighty scholarly publications on elder abuse or related interventions, including the books *The Etiology of Elder Abuse by Adult Offspring* and *The Clinical Management of Elder Abuse*; was the architect of Ohio's adult protective services law; led in the establishment of the oldest state and local elder abuse networks in the United States; and was the 2005 recipient of the Rosalie S. Wolf Memorial Elder Abuse Prevention Award—National Category.

### Staci Converse, Managing Attorney

Staci Converse leads Disability Rights Maine's (DRM) developmental disabilities team of eight advocates and attorneys. She has litigated on a variety of civil rights issues such as access to Medicaid community-based services, compliance with the Americans with Disabilities Act, and contesting guardianship. Staci was DRM's lead attorney in *Van Meter v. Mayhew*, a class-action lawsuit that forced the Maine Department of Health and Human Services to provide services to people with developmental disabilities so they can live in the community. She has trained extensively on alternatives to guardianship and Supported Decision-Making (SDM). She recently published *Guardianship Reform: Supported Decision-Making and Maine's New Probate Code* in the Fall/Winter 2018 edition of the Maine Bar Journal.

Prior to joining DRM in 2008, she was an attorney specializing in special education law, a member of DRM's Board of Directors, and a law clerk to Justice Susan Calkins of the Maine Supreme Judicial Court. Staci holds degrees from the University Of Maine School Of Law and the University of Texas at Austin.
