Presentation: Nadine Grosso, Vice President and Director of Communications Maine Health Care Association

-87 out of 88 nursing homes are members of MEHCA along with 125 assisted living facilities.

- MEHCA supported the healthcare mandate for LTC facilities-seeing high vaccination rates in residents and staff.
- Currently 29 nursing homes are in outbreak status but seeing less severe cases.
- In the process of ensuing booster clinics are held in nursing homes- most facilities have had clinics already- working through Assisted Living now.
- Visitation in long-term care has been a huge concern/ struggle.
- In the beginning of COVID all facilities were in lock down due to recommendations from CMS, the US and ME CDC. The isolation had a huge impact on residents. Visitation evolved overtime- in summer months outdoor visits occurred along with scheduled visits following infection control. Now CMS releases new guidance before thanksgiving allowing doors to be open again while following infection control.
- MEHCA is helping facilities navigate and implement this new guidance.
- MEHCA helped facilitate family groups via zoom in partnership with the Maine Long-Term Care Ombudsman Program.
- Staffing- MEHCA has surveyed members on staffing in two different categories
 - 1. Vacant positions
 - 2. Why are staff leaving?
- Over 50 percent of members have 3 to 10 vacant staff positions.

- Reasons for this staffing crisis-
 - 1. Burn out and stress
 - 2. Vaccine mandate- roughly 1,800 works left
 - 3. Leaving healthcare all together because it is tiring
 - 4. Mental health

-Trying to fill these staffing vaccines with temp nursing programs, role of the facility members and agency staffing.

-hospitals are backed up causing a capacity issue.

-Long-term care facilities are limiting admissions due to no staffing to care for residents.

- The committee is focusing on elder abuse summit in May which will be two half days.

- Piloted a program in 2018 demonstration program in CU and AR county this has expanded to all counties in Maine. Elder institute of Maine is partnered with this piloting program. This allows a client to have a warm hand off with an elder advocate.
- Public service announcement for Mandatory Reporting.
- APS is working with forensic accountants across the state on a case-by-case basis.

- LSE has two new staff attorneys
- Helpline continues to work remotely offering same services. Seeing more acute cases.

- Increase in helpline support
- Courts are not always open to file PFA
- Offering in-person support by appointment
- Shelter has been at capacity
