Elder Abuse Task Forces Across the State:

Nicole Marchesi, Co- Chair of Tri-County EATF-

- Shortly before the pandemic AN, OX and FR combined forces to become the Tri-County EATF
- The task force meets the first Tuesday of every month via zoom from 10am-11am.
- Each meeting allows time for community partner updates, a guest speaker and case discussion/referral.
- Before COVID each individual County hosted resource fairs to provide education and knowledge to community members these have been on hold due to the pandemic.
- The group is comprised of many different agencies providing support on preventing and supporting consumers around elder abuse issues.
- One of the many benefits of attending the counsel is becoming educated about each individual agency to better serve the consumers.

The purpose of the Greater Augusta Elder Abuse Task Force is to raise awareness about the problem of elder abuse to the communities of the Greater Augusta area. We are a group of community service providers who work to accomplish our mission through:

- Offering educational trainings to seniors and community groups,
- Organizing and participating in community events, and
- Networking to coordinate a multi-disciplinary response to situations of reported elder abuse.

Brief History

In 2004 the Greater Augusta Area Elder Abuse Task Force was established through a collaboration of member organizations. The goal of the Task Force was to make a multi-disciplinary team available to those who provide community response and assistance to elder persons at risk of abuse, neglect, or financial exploitation. Karen Elliot, who worked at Adult Protective and was a board member of Family Violence Project, initiated this effort. Until the Co-Vid Pandemic, the meetings were held at Augusta City Hall. For the past couple of years, the co-chairs have been Nicole Marchesi from the Long-Term Care Ombudsman Program, and myself. We have monthly meetings via zoom, a robust email listserv, and had planned a Resource Fair for October of 2019 which was cancelled. Our monthly meeting features a speaker from the community who will educate and share about resources available to help prevent elder abuse. We have had some printed materials distributed and some small media write ups.
