Overview:

Normal Aging vs. Dementia

Alzheimer's and Dementia: What's the difference

• 68 percent of all dementia cases are caused by Alzheimer's

Risk Factors:

- Age greatest risk factor
- Family history- parent or sibling with Alzheimer's is an increased risk factor
- Certain populations are at higher risk of developing Alzheimer's

10 Warning Signs:

- 1. Memory loss that disrupts daily life
- **2.** Challenges in planning or solving problems
- 3. Difficulty completing familiar tasks
- **4.** Confusion w/ time or place
- 5. Trouble understanding visual images and spatial relationships

- **6.** New problems with words in speaking or writing
- 7. Misplacing things and losing the ability to retake steps
- **8.** Decreased or poor judgement
- **9.** Withdrawal from work or social activities
- 10. Changes in mood and personality

Early Detection & Diagnoses:

- Benefits:
 - o Able to have a voice of what happens next
 - Wishes of care and personal
 - o Financial plans
 - o Time for family to make plans

General Stats:

- More than 6 million ppl currently living w/ Alzheimer's
- 11 million providing unpaid care unpaid care
- 30,000 in Maine living with disease that we know of

Erin Salvo, APS:

Updates:

- Investments proposed to support older Mainers:
 - o Continue funding Rise Program: Elder Services Connections Program
 - Partnership with APS and Elder Abuse Institute of Maine
 - Provide support after APS case is closed, build a relationship with client.
 - If a client is engaged in the Rise Program 60 percent less likely to return to APS as a client
 - Continue Good and Services Pilot:
 - Make immediate purchases for clients, ranging from groceries, winter coats, walker, new mattress, paid for cleaning services so in home supports will return to provide care.
 - Add positions to APS within the recommendations from Elder Justice Roadmap
 - Seeing increase in reports, over 1,000 reports a month.
- American Rescue Plan
 - Working with Muskie team to put out an annual report, reflect two fiscal years.
 - Ranging from information on who reports to APS what percentage are mandated reported, who are our clients, etc.
 - 30,000 in Maine living with disease that we know of
- LD 35 bill moving through legislation.
 - o An act to require mandated reporters to receive training
 - o Public hearing scheduled for March 15th
 - o Top recommendations from Elder Abuse Justice Road Map

Overview of Committees and Work Groups:

Education and Awareness Committee (Jill Randall):

- Focused on Elder Abuse Summit and Round Table to provide education across the state: if interested in joining the Education and Awareness reach out to Jill Randall.
- Focused on Elder Abuse Summit in May, working on finalizing the agenda and sending out registration.
- Elder Abuse Summit is virtual.
- Round Table hoping will return to in-person event.
