## **Presentations:**

Angela Hamlin- Co-Chair, Greater Augusta Elder Abuse Task Force

- The task force is a way to look for resources and connections.
- All meetings on zoom, meet once a month.
- Membership consists of APS, social agencies, resident coordinators, bankers, LTCOP, legal services, homeless shelters, mental health providers.
- An educational speaker joins to share information about services.
- The goal is to educate the community. In the past, placemats displaying local resources have been provided through Meals on Wheels.
- The benefit of joining the task force is to connect and network about resources.

Danielle Malcolm, Co-Chair, Tri-County Elder Abuse Task Force

- Covers Franklin, Oxford, and Androscoggin counties.
- Meets once a month via zoom.
- The task force is in a rebuilding stage for membership. They recently sent out a survey to understand what dates and times work best for the meetings.
- In 2023, there was a lot of turnover in positions.

• No representation from financial or law enforcement.

Anna Duella, York County Elder Abuse Task Force

- Public health intern from UNE working on a project on wellness and aging in Kennebunkport.
- 12 members make the core of the task force.
- 4 board members.
- Membership consists of financial, law enforcement, DV and public health.
- Once a month meeting.
- The goal is for outreach, education and raising awareness.
- Grant recently awarded called the Educational Road Show.
  - 6-7 events at community centers
  - Conduct short presentations on elder abuse
  - Partnered with food organization to build meal bags for community members
- Last year, awarded a grant for police officers to have pocket amplifiers.
- 16<sup>th</sup> year of hosting annual conference.
- Projects on elder well being
  - "wishing well"
    - To qualify over the age of 60
    - York County resident
    - Submit own wish "bucket list item"
