Lisa R. Bogue, Esq. graduated from Mt. Blue High School in 1992. In 1997, she graduated Magna Cum Laude from the University of Maine at Orono with a degree in Policial Science and in 2003 graduated Cum Laude from University of Maine School of Law earning the Faculty Award for Trial Advocacy. Following graduation, Lisa was hired to work as an Assistant District Attorney in Lincoln and Sagadahoc Counties. While working in that capacity, she prosecuted all levels of criminal cases including child sexual abuse cases, domestic abuse cases and vehicular manslaughters. In 2008, she was hired as an Assistant Attorney General to work in the Heath Care Crimes Unit and later moving within the Office of the Attorney General to work as the Mid-Coast Drug Task Force prosecutor. From 2013-2019, Lisa prosecuted felony sexual assault and violent felonies in Androscoggin County. She returned to the Office of the Attorney General in 2019 to be one of four statewide homicide prosecutors.

Lisa chairs the Domestic Violence Homicide Review Panel since the retirement of long-time chair, Lisa Marchese. While an ADA, she was appointed to be a member of the Sexual Assault Forensic Examiners Board, served as a team member of the multidisciplinary team of Androscoggin Child Advocacy Center, and served as a co-adviser of the Advisory Team for the Androscoggin, Franklin and Oxford County Child Advocacy Centers. In 2016, the Children's Advocacy Center of Androscoggin, Franklin and Oxford Counties awarded her the Community Advocate Award.

In 2025, Attorney General Aaron Frey promoted Lisa to Deputy Attorney General and Chief of the Criminal Division.
